Introduction

The statistics on the care provided by the Hospitaller Order of St John of God in 2019 were collected by means of questionnaires sent out to 423 centres (-3 fewer than in 2018). Eventually, 405 questionnaires, or 96%, were compiled and returned. The provincial breakdown of the questionnaires returned completed is shown in Table 1

353 centres supplied the following information on the type of ownership/management, which coincides with the 2018 situation.:

- 89% belong to the Order,
- 4% are jointly owned with other entities,
- 7% are being managed on behalf of another entity.

With regard to properties belonging to the Order, 72% (the same as in 2018) the care services are under a lay General Manager, while 13% (the same as in 2018) are managed by a Hospitaller Brother, and the rest (15%) are managed by the Community Prior (15% in 2018). 8% of the jointly-owned centres have another Hospitaller Brother as the General Manager of their care work, and 92% have

a lay General Manager, both unchanged since 2018. Lastly, 91% (as in 2018) of the 32 facilities (as in 2018) managed on behalf of another entity are headed by a lay manager, and 9% (9% as in 2018) by the Community Prior.

These 423 facilities deliver their services in the following care categories:

- 82 hospitals (81 questionnaires returned)
- 56 non-hospital (primary health care) facilities) (55 questionnaires returned)
- 63 centres for people with mental disabilities (61 questionnaires returned)
- 77 centres for people with physical, mental, sensorial disabilities (68 questionnaires returned)
- 38 centres for the elderly (36 questionnaires returned)
- 77 miscellaneous social-welfare facilities (75 questionnaires returned)
- 30 Formation Centres (29 questionnaires returned).





As for the continental breakdown, the 423 facilities were mostly in Europe and North America in 2019 (74%), followed by South and Central America (11%), Asia (9%), and Africa (6%).




Diagram 1 The care centres that replied to the questionnaire by geographic location. 2019

Beds, inpatients, and daily stays

In 2019 we had a total of 37,734 beds (an increase of 541 over 2018 1.5%) with 821,978 admissions (-131,347 fewer than in 2018, -5%) to total 10,891,328 daily stays (601,041 fewer than in 2018, -5%). The figure for total daily stays makes it possible to estimate that every day the Order's facilities provide a bed for about 30,000 people worldwide, in line with 2018. The reduction in admissions and daily stays, despite the substantially unchanged the number of beds, can be put down to the downturn in work reported by some Provinces, or to failure to complete the questionnaire and the specific field.

The following tables show the breakdown of the numbers of beds, inpatients and daily stays by Province, care category and geographical location.

Day Hospitals, Day Surgeries, Day Care, nonhospital care, and pharmacies and herbalists

For care categories A, B and C it is not only possible to count the number of 'ordinary admissions' but also treatments in Day Hospitals, Day Surgeries, Day Care centres and outpatient treatments.

In 2019, the Day Hospitals, Day Surgeries, Day Care centres admitted 360,262 patients (Table 6), 31,685 fewer than in 2018 (-8%).

22,151,430 outpatient treatments were delivered in 2019 (Table 7), an increase of 1,125,361 over 2018 (+5.4%).

Home care and other services

In 2018 the Order's facilities provided home care to 23,728 people. In 2019 this figure had fallen to 19,144 (4,584 fewer). More specifically, the Order's hospital facilities (category A) provided home care for 16,915, 1,852 fewer (-10%) than in 2018, broken down by care subcategories as shown in Table 8.

- Basic personal conduct (personal grooming, behaviour, etc.)
- Training and schooling (special education, special vocational training)
- Consultancy and counselling (for home-seekers, job-seekers, etc.)
- Occupational activities (laboratories, workshops, sheltered occupations)
- Day centres
- Canteens

Personnel

The total number of personnel was 65,518 (an increase of 760 over 2018, +1%), broken down as follows: Hospitaller Brothers 542, other Religious 290, lay employees 61,850 and lay consultants 2,576. In addition to the lay employees and consultants in the 175 centres that replied to the questionnaire, 5,055 people were employed by outsourced companies (4,944 in 2018). Diagram 2 Number of employees by care category 2019



Volunteers

The Order's centres have a total of 25,387 volunteers. Once again, a substantial percentage are provided by the Good Shepherd Province, while there was a sharp decline in the Korean Province (-5,809 fewer than in 2018, -57%), due to an extraordinary event in 2018, that required more volunteers. Tables 13 and 14 show the breakdown of the number of volunteers by Province and care category.

The centres which replied reported that a total of 8,182 volunteers were present at least once a week, making a total of di 17,205 volunteers.



Funding

In order to calculate how care activities were financed, we asked for the percentage funding breakdown of 2019 expenditure. Having set the total at 100%, each centre needed to indicate the percentage of income received from: 1) central or local government or other public bodies, 2) Paying guests, businesses and private insurances, 3) Charities, 4) Other sources, About 50% of the funding received by the responding facilities came from central or local government or other public bodies, while 24% came from paying guests, businesses, private insurances, 10% came from charities, and 9% from Other sources.

It is worth noting that the averages given may vary considerable between Provinces as well as between care categories. Table 20 therefore shows the average funding figures by care category (in columns) and by Province (in rows). To simplify things, the table only shows the funding provided by public entities and government. The table clearly reveals the variability between Provinces and also within the same care category: by way of example, the average percentage of public financing of the centres in the Good Shepherd Province was 60%, while the same breakdown for Andalusia Province was 38%, and Africa St R.Pampuri Province was 1%.

With regard to the financing of investments decided in 2019, the replying facilities report that 44% came from self-financing by the service, 11% from central or local government or other public bodies, 4% from private contributions, and 11% from grants provided by the Order.
