Introduzione

The statistics on the care provided by the Hospitaller Order of St John of God in 2020 were collected by means of questionnaires sent out to 413 centres.

There were 11 Centres fewer than in 2019 due to the amalgamation and reclassification of a few Centres in the Bavarian and Polish Provinces.

Although the Order managed to largely maintain levels of care, the impact of the Covid-19 pandemic was still felt in some areas in 2020.

At the end of the survey, 384 questionnaires were completed. The completion rate (coverage) reached 93%.

Table 1 shows the breakdown by province of the questionnaires returned completed.

For 354 centres, we have data on the type of ownership/management, the distribution of which overlaps with that of 2019, with a slight decrease in ownership by the Order and a slight increase in management on behalf of another entity

- 87% belong to the Order,
- 4% are jointly owned with other entities,
- 9% are being managed on behalf of another entity.

Of the structures owned by the Order, 74% (a slightly higher percentage than in 2019) entrust the general management of care services to a lay person, 13% (the same percentage as in 2019) to another Brother of the Order, and for the remaining structures (13%) to the Prior of the Community (15% in 2019). Of the structures jointly-owned managed with other entities, 7% (only 1 centre) entrust the general management of care services to another Brother of the Order and 93% to a lay person, in both cases the percentages are very similar to those of 2019. Finally, of the 31 Centres (32 in 2019) managed on behalf of another entity, 87% (91% in 2019) are managed by a lay person and 10% (9% in 2019) by the Community Prior.

These 412 facilities deliver their services in the following care categories:

- 80 hospitals (77 questionnaires returned)
- 52 non-hospital (primary health care) facilities) (50 questionnaires returned)
- 64 Centres for people with mental disabilities (61 questionnaires returned)
- 68 Centres for people with physical, mental, sensorial disabilities (58 questionnaires returned)
- 43 Centres for the elderly (37 questionnaires returned)
- 75 miscellaneous social-welfare facilities (72 questionnaires returned)
- 30 Formation Centres (29 questionnaires returned).






As for the continental breakdown, the 412 facilities were mostly in Europe and North America in 2020 (73%), followed by South and Central America (11%), Asia (9%), and Africa (7%).

Beds, inpatients, and daily stays

In 2020 we had a total of 39,048 beds (an increase of 1,314 over 2019, or 3%) with, with 755,092 admissions (-66,886 fewer than in 2019, -8%) to total 9,633,584 daily stays (1,257,744 fewer than in 2019, -12%). The figure for total daily stays makes it possible to estimate that every day the Order's facilities provide a bed for about 26,000 people worldwide. The reduction in admissions and daily stays, despite the substantially unchanged number of beds, can be put down to the downturn in work reported by some Provinces, or to failure to complete the questionnaire and the specific field. The following tables show the breakdown of the numbers of beds, inpatients and daily stays by Province, care category and geographical location.

Day Hospitals, Day Surgeries, Day Care, nonhospital care, and pharmacies and herbalists

For care categories A, B and C it is not only possible to count the number of 'ordinary admissions' but also treatments in Day Hospitals, Day Surgeries, Day Care centres and outpatient treatments.

In 2020 the Day Hospitals, Day Surgeries, Day Care centres admitted 321,228 (Table 6), 39,034 fewer than in 2019 (-11%).

12,452,676 outpatient treatments were delivered in 2020 (Table 7), 9,698,754 fewer than in 2019 (-44%). This difference is due to errors made by one Province in previous years' calculations.

Home care and other services

In 2019 the Order's facilities provided home care to 19,144 people. In 2020 this figure had risen to 23,806 (4,662 more). More specifically, the Order's hospital facilities (category A) provided home care for 22,216 people, 5,301 more (+31%) than in 2019. broken down by care subcategories as shown in Table 8.

- Basic personal conduct (personal grooming, behaviour, etc.)
- Training and schooling (special education, special vocational training)
- Consultancy and counselling (for home-seekers, job-seekers, etc.)
- Occupational activities (laboratories, workshops, sheltered occupations)
- Day centres
- Canteens

Personnel

The total number of personnel was 65,080 unità (178 fewer than in 2019, +0.1%), broken down as follows: Hospitaller Brothers 351, other Religious 261, lay employees 61,948 and lay consultants 2,520. In addition to the lay employees and consultants in the 175 centres that replied to the questionnaire, 5, people were employed by outsourced companies (5.055 nel 2019). Diagram 3 Number of employees by care category, 2020



Volunteers

The Order's centres have a total of 5,967 volunteers. Overall, there was a sharp reduction compared to 2019 (-19,420, -76%). Specifically, there was a significant reduction in the Good Shepherd Province (-12,570 compared to 2019, -95%) and the Korean Province (-4,097, -93%). Tables 13 and 14 show the distribution of volunteers by province and by care category.

The centres which replied reported that a total of 4,367 volunteers were present at least once a week, making a grand total of 1,600 volunteers.



Funding

In order to calculate how care activities were financed, we asked for the percentage funding breakdown of 2020 expenditure. Having set the total at 100%, each centre needed to indicate the percentage of income received from: 1) central or local government or other public bodies, 2) Paying guests, businesses and private insurances, 3) Charities, 4) Other sources, About 48% of the funding received by the responding facilities came from central or local government or other public bodies, while 24% came from paying guests, businesses, private insurances, 10% came from charities, and 8% from Other sources.

It should be noted that the averages given may vary considerable between Provinces as well as between care categories. Table 20 therefore shows the average funding figures by care category (in columns) and by Province (in rows). To simplify things, the table only shows the funding provided by public entities and government. The table clearly reveals the variability between Provinces and also within the same care category: by way of example, the average percentage of public financing of the centres in the Good Shepherd Province was 62%, while the same breakdown for Andalusia Province was 43%, and Africa St R.Pampuri Province was 2%.

With regard to the financing of investments decided in 2020, the replying facilities report that 37% came from self-financing by the service, 10% from central or local government or other public bodies, 4% from private contributions, and 9% from grants provided by the Order.
